IT IS ORDERED AS FOLLOWS:

1. Plaintiff shall have to and including September 15, 2011 to file responses to Defendant's First Interrogatories and Requests for Documents and to produce documents.
2. Defendant shall have to and including September 30, 2011 to file responses to Plaintiff's First Interrogatories and Request for Documents and to produce documents.
3. Plaintiff's deposition is scheduled for October 25, 26, 27, 2011 and November 1 and 2, 2011.
4. Depositions of John L. Gatt, Edward Vogt, Kim Howe, Don Johnson, Kurt McNeil are scheduled to be taken during the period of November 7 - 11, 2011.
5. Plaintiff shall file its motion for certification of the purported class on or before December 1, 2011.
6. Defendant shall file its response to Plaintiff's motion for certification of the purported class on or before December 22, 2011.
7. An evidentiary hearing on Plaintiff's motion for certification of the purported class shall be scheduled by the Court.




